ATTORNEYS REPORT

Discussion was held in regards to a complaint we received about Anhydrous Ammonia being hauled on Prospect Ave. Hall Road off of Highway 52 was build to haul the product in and out of town without having to go down Prospect Ave. Blotter stated at this time we have no Ordinance in place stating Anhydrous Ammonia cannot be traveled through City limits. Public feedback is being requested. We will have Attorney Jim Wilson check on different ordinances in regards to hauling Anhydrous Ammonia through City Limits. Campbell and Bechtold both stated that all tanks are checked for leaks and have to pass an inspection before they can be filled. William Bechtold and Eric Griffin both stated they use Prospect Ave rather than going out on Highway 52 due to traffic issues. Keller also stated he hauls Anhydrous once in a while and he does use Prospect Ave due to the traffic flow on Highway 52.
