AUDITOR

Johns gave an update on the water meter replacement project. Wyche has found several homes that have continuous flow through their water meters, either from a running toilet or outside spigot/sprinkler leaking. Wyche has been contacting home owners as soon as an issue is detected. The Public Works department is working hard to get meters installed along with their other duties. Johns gave an audit update, stating years 2014 and 2015 will be done this week. 2014 will be an official completion and 2015 will be an opinion disclaimer.

PUBLIC WORKS

Johns stated that the Public Works Department has located a pickup for sale in Minot that they think will work for their department. Johns discussed funding for the vehicle.
