Street Commissioner: Keller paving patched water break spots in town and Heritage Drive.

AUDITOR REPORT

Park bridge approval bid from Industrial Builders, Inc. discussed. Motion Keller/Davis to approve the bid from IBI and the cost (\$18,830.10) of paving streets at the end of the bridges.

BUILDING INSPECTOR/ASSESSOR

Discussed Dakota Agronomy building permit for fertilizer bins. Permit approved by Building Committee.

ENGINEERING

Alan Walter presented a water billing evaluation on water rates in Velva and surrounding cites. His evaluation showed Velva had one of the lowest rates in the area and suggested the City raise rates to cover water costs. Walter stated the City should raise the base water rate from \$13.00 to \$15.00. Motion Zietz/Davis to raise water rates from \$13.00 to \$15.00 starting January 1, 2019. Roll Call Vote: Foley-Yes; Zietz-Yes; Davis-Yes; Soli-Yes; Keller-Yes. Motion Carried.

Walter discussed with the Commission that the City needs to pay the \$44,284.39 SRJB bill. Motion Keller/Foley to write a payment plan letter to SRJB for \$5,000.00 a year. All ayes. Motion carried.
